WHEREAS the IOC Disciplinary Commission has considered the facts and arguments submitted by the Parties,

WHEREAS the Parties have been heard at the hearing of the IOC Disciplinary Commission held on 13 November 2017,

WHEREAS the IOC Disciplinary Commission will issue its motivated decision within a reasonable time after the notification of the present decision,

PURSUANT to the Olympic Charter and, in particular, Rule 59.2.1 thereof, and pursuant to The International Olympic Committee Anti-Doping Rules applicable to the XXII Olympic Winter Games in Sochi, in 2014 and, in particular, Articles 1, 2, 6, 7, 8 and 9 thereof

THE DISCIPLINARY COMMISSION OF THE
INTERNATIONAL OLYMPIC COMMITTEE
RULES

- I. The Athlete, Dmitrii TRUNENKOV:
 - a) is found to have committed anti-doping rule violations pursuant to Article 2 of The International Olympic Committee Anti-Doping Rules applicable to the XXII Olympic Winter Games in Sochi, in 2014;
 - b) is disqualified from the event in which he participated upon the occasion of the XXII Olympic Winter Games in Sochi, in 2014, namely the Four-man's Bobsleigh Event, in which he ranked 1st and for which he was awarded a gold medal, a medallist pin and a diploma;
 - c) has the medal, medallist pin and the diploma obtained in the above-mentioned Event withdrawn and is ordered to return the same to the International Olympic Committee.
- II. The Russian Team is disqualified from the Four-Man's Bobsleigh Event¹. The corresponding medals, medallist pins and diplomas are withdrawn and shall be returned to the International Olympic Committee.
- III. The International Bobsleigh and Skeleton Federation is requested to modify the results of the above-mentioned event accordingly and to consider any further action within its own competence.
- IV. Dmitrii TRUNENKOV is declared ineligible to be accredited in any capacity for all editions of the Games of the Olympiad and the Olympic Winter Games subsequent to the Sochi Olympic Winter Games.
- V. The Russian Olympic Committee shall ensure full implementation of this decision.

¹ The results of Mr Aleksandr ZUBKOV (SML – 028) and Mr Aleksei NEGODAILO have been disqualified as per the decisions of the Disciplinary Commission issued respectively on 24 November 2017 and 27 November 2017.

VI. The Russian Olympic Committee shall notably secure the return to the International Olympic Committee, as soon as possible, of the medals, medallist pins and the diplomas awarded in connection with the Four-Man's Bobsleigh Event² to the members of the Russian Team.


VII. This decision enters into force immediately.
